## **GOVERNANCE UPDATE FOR REGIONS FROM PROVINCIAL COUNCIL**

The 4-H Council of Alberta held our regular fall meeting on October 25<sup>th</sup> at the 4-H Centre. We discussed a number of topics, and those highlights (included below) will be sent out to the regions as always. There are a few that will also be mentioned in this update regarding governance, and information regarding Council income and expenses.

We have started to receive some feedback from a few regions regarding the 4-H Alberta governance proposal. We appreciate those who have taken the time to give constructive feedback. In order for the 4-H community to have a full understanding of the summary of the process, you are encouraged to read through the material.

*The documents that best summarize the process are:*

- a) The summary of the May 2013 meeting,
- b) The proposal,
- c) The September 13, 2014 meeting summary, and
- d) A flowchart of the concept which the proposal presents. The flowchart was just created during the recent Council meeting, so this is a new addition to the information; hopefully it will help with an understanding of the concept.

All 4-H Alberta Council directors have numerous copies of all of the items listed. Please contact your region's director for more information, or for copies of these items. The regional reps who attended the September meeting will provide an overview of things but if you have specific questions that you need clarification on, Council directors can provide answers to those questions.

One thing we would like to encourage moving forward is that we aren't looking for a yes or no answer regarding the proposal, but rather we would like to encourage everyone to look through the main details of the proposal, and if there are specific parts that you don't understand or agree with, please explain why and offer constructive alternatives to those specific areas. Please understand there is currently no timeline on this process. We are at the stage where we simply want to encourage a conversation about specific pros and cons.

We also invited the A/ADM of Alberta Agriculture and Rural Development to attend our Provincial Council meeting. ADM John Brown graciously attended, and we had a very thorough conversation about the current state of 4-H Alberta governance. We also discussed ways that we all might work more productively together to collaborate in the interim. All involved considered it a very positive and encouraging conversation, and we look forward to working more on this collaborative approach.

### **4-H Council of Alberta Financial Information**

For the 2013-2014 club year the 4-H Council of Alberta fees are \$20 per member. Invoices to regional Presidents and Regional Directors will be soon circulated.

Each year the 4-H Council of Alberta's financial information is reviewed by an outside firm within one of the three levels of assessments listed below. The approved financial statement is available for review and also can be found in the 4-H Alberta Annual Report. The 4-H Council of Alberta has graciously been provided substantial operational revenue by one of our Partners, the 4-H Foundation of Alberta. They have access to funds that can be utilized to support the 4-H program in Alberta. Without that assistance the last two years, the 4-H Council of Alberta would have had a statement with a significant deficit.

For the year end of 2013 a Notice to Reader was completed by Grant Thornton. They recommended a Notice to Reader was an efficient assessment and they also indicated that a full audit is not required each year.

*There are three levels assessments:*

1. *Audit* - Audits provide an opinion, all documents and transactions are reviewed, sample testing is completed to make sure there are no issues and they retain all source documents from the client.

2. *Review Engagement* - The 4-H Council of Alberta had a Review Engagement done in 2012. Review engagements, review very few source documents. They follow a computer program that numbers are entered from financial statements, to ensure there are not red flags. A full understanding of what is going on is obtained. The company provides five notes to help interpret the numbers, they have more formal conversations with finance departments and all information is processed in their office and they retain certain information for their records. The final statement will look the same as a notice to reader with and addition of three notes.

3. *Notice to Reader* - All 4-H Council of Alberta's revenue and expenses were reviewed as the same process as that of a review engagement. Two notes are provided with the financial statement, the company retains no documents for their records and the total expense was \$1500 less than that of a Review of Engagement.

Grant Thornton indicated that they were very comfortable with the numbers that were put before them and feel the 4-H Council of Alberta's financial records are straight forward and easily understood. They do a quality job and go beyond many other companies when a notice to reader is provided as it follows their standards.
